

ATHLETIC FACILITY USER AGREEMENT

Montpelier Exempted Village Schools Participation Waiver (Board Policy 7510 Re. 12/12/17)

Please read this form carefully and be aware that your signature indicates that you fully understand that by using the Montpelier School's athletic facilities you will be waiving and releasing all claims for injuries you might sustain arising out of this program.

Turf area and athletic equipment are not open to the public and are for use by Montpelier student athletes only.

Rules and Expectations of Montpelier Athletic Facilities

1. Student activities take precedent over public usage.
2. All students need to be supervised by an adult.
3. Damaged equipment needs to be reported to the Montpelier Athletic Director at (419) 485-6785.
4. Please return all equipment to the location in which you found it.
5. If you would like to reserve the facility you need to contact the Montpelier Athletic Director at (419) 485-6785.
6. Misuse of the equipment or facility may result in removal of access to the facility.
7. Tennis shoes only are to be worn in athletic facilities. Cleats and spikes are not allowed.
8. Please refrain from bringing outside food and drinks into the athletic facilities

WARNING OF RISK

Aerobic and other fitness exercises including such items as passive/resistance weight training, use of stair climbers, treadmills, and other training devices, despite careful and proper preparation, instruction and medical advice, conditioning, and equipment, pose a substantial risk of injury. You are responsible for determining if you are physically fit for these activities. It is advisable to consult a physician before undertaking a physical exercise program.

I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries (including death), damages or loss that I may sustain as a result of using the Montpelier School's Recreation Center and/or Weight Room facilities or equipment and all activities connected with or associated with such facilities. I agree to waive and relinquish all claims I may have as a result of participating in the program against the District and its officers, agents, servants, and employees. I do hereby fully release and discharge the District and its officers, agents, servants and employees from all claims resulting from injuries, damages and losses sustained by me arising out of, connected with or in any way associated with the activities of the program. In any event of any emergency, I authorize the District to secure from any licensed hospital, physicians and/or medical personnel any treatment deemed necessary for my immediate care and agree that I will be responsible for payment of any and all medical services rendered. I have read and fully understand the above risk warnings of the program, Waiver and Release of All Claims and Permission to Secure Treatment.

RELEASE FROM LIABILITY

In consideration of the use of the Recreation Center and/or Weight Room facilities and equipment, and in recognition of the possible perils of the use of exercise facilities, the undersigned, for himself and his heirs, executors, administrators, and assigns, does hereby release the District from any liability, obligation, or responsibility for injuries sustained from the use of such facilities, including equipment herein, and waives all claims which the undersigned might have against the said District arising from those mentioned and any others acting upon their behalf from any responsibility or liability for any injury or damage to myself, including those caused by the negligent act or omission of any of those mentioned or others acting on their behalf or in any way arising out of or connected with my participation in any activities of weight training or the use of any equipment at Montpelier Schools.

I understand and am aware that strength, flexibility, and aerobic exercise, including the use of equipment, are a potentially hazardous activity. I also understand that fitness activities involve a risk of injury and even death, and that I am voluntarily participating in these activities and using equipment and machinery with knowledge of the dangers involved. I hereby agree to expressly assume and accept any and all risk of injury or death.
